CHAPTER 7 MISCELLANEOUS

The person responsible then has the opportunity to respond to this NOTICE. If the person responsible has not (fully) reacted within 5 (five) working days, MINDZ.com shall deem itself entitled to cease the transmission of the illegal content and/or remove the illegal content and/or to disclose the name, address and residence of the provider of the information, provided that MINDZ.com has no reason whatsoever to doubt the correctness of the requester's NOTICE. With regard to a request to disclose personal data of the provider of information, MINDZ.com shall weigh up the interest of the parties involved. MINDZ.com shall retain the right not to comply with the request.
